MEDIMPACT HEALTHCARE SYSTEMS, INC. BE DENIED AND DISALLOWED**


NOW INTO COURT, through undersigned counsel comes, James J. Donelon, Commissioner of Insurance for the State of Louisiana as Liquidator for AmCare Health Plans of Louisiana, Inc. In Liquidation, through the Court-appointed Deputy Receiver, Marlon Harrison ("AmCare-LA"), who suggests to the Court that a stipulation was entered in this matter by AmCare-LA and MedImpact HealthCare Systems, Inc. ("MedImpact"). On March 26, 2012 that a hearing would be set on or before May 15, 2012 to consider the proof of claim submitted by MedImpact to consider the objection of Med Impact Health to the Receiver's Recommendation to the Court that the MedImpact claim should not be approved and allowed.
