Pursuant to section 2701(a)(2) of the Public Health Service Act and 45 C.F.R. 147.103(a)(3), the state of Louisiana has established eight (8) geographic rating areas in accordance with 45 C.F.R. 147.102(b). The geographic rating areas are applicable to the individual and small group markets for plan or policy years beginning on or after January 1, 2014. Grandfathered health plans or policies are exempt from the provisions of Bulletin 2013-01.

The Centers for Medicare and Medicaid Services has approved Louisiana's submission of geographic rating areas under 45 C.F.R. Part 147. The division of geographic rating areas for the 2014 plan or policy year is attached to Bulletin 2013-01 as Appendix A.
