Dear Commissioner Donelon:

On behalf of Elevance Health, we are notifying you that effective immediately the Applicants are hereby withdrawing the following as submitted to the Louisiana Department of Insurance (the "<u>Department</u>") on January 23, 2023: (i) the Application for a Change of Control, which includes as an exhibit the Form A Statement filed in accordance with Louisiana Revised Statutes § 22:691.4, as relates to the Applicants' proposed acquisition of control of BCBSLA, HMO LA, SNLIC, VHP and CCHP; and (ii) the associated Form E Exemption Notice filed pursuant to Louisiana Revised Statutes § 22:691.5. The Applicants remain committed to the transaction and intend to re-file in the near future.

We are further requesting that the Department maintain the confidentiality of the confidential documents and information submitted in connection with the above referenced filings in accordance with all applicable laws.
